



Salto Gymnastics Club: Website Privacy Policy

1. Introduction

1.1 We are committed to safeguarding the privacy of our website visitors; in this policy we explain how we will treat your personal information.

1.2 By using our website and agreeing to this policy, you consent to our use of cookies in accordance with the terms of this policy.

2. Collecting Personal Information

2.1 We may collect, store, and use the following kinds of personal information:

(a) information about your computer and about your visits to and use of this website (including your IP address, geographical location, browser type and version, operating system, referral source, length of visit, page views and website navigation paths).

(b) information that you provide to us when registering with our website (including [your email address]).

(c) information that you provide when completing your profile on our website (including your name, profile pictures, gender, date of birth, relationship status, interests and hobbies, educational details, and employment details).

(d) information that you provide to us for the purpose of subscribing to our email notifications and/or newsletters (including your name and email address).

(e) information that you provide to us when using the services on our website, or that is generated in the course of the use of those services (including [the timing, frequency, and pattern of service use]).

(f) information relating to any purchases you make of goods and/or services or any other transactions that you enter into through our website (including your name, address, telephone number, email address).

(g) information that you post to our website for publication on the internet (including your username, your profile pictures, and the content of your posts).

(h) information contained in or relating to any communication that you send to us or send through our website (including the communication content and metadata associated with the communication);

(i) any other personal information that you choose to send to us.

2.2 Before you disclose to us the personal information of another person, you must obtain that person's consent to both the disclosure and the processing of that personal information in accordance with this policy.



3. Using Personal Information

3.1 Personal information submitted to us through our website will be used for the purposes specified in this policy or on the relevant pages of the website.

3.2 We may use your personal information to:

- (a) administer our website and business.
- (b) personalise our website for you.
- (c) enable your use of the services available on our website.
- (d) send you goods purchased through our website.
- (e) supply to you services purchased through our website.
- (f) send statements, invoices and payment reminders to you, and collect payments from you.
- (g) send you non-marketing commercial communication.
- (h) send you email notifications that you have specifically requested.
- (i) send you our email newsletter, if you have requested it (you can inform us at any time if you no longer require the newsletter or unsubscribe).
- (j) send you marketing communications relating to SALTO which we think may be of interest to you, by post or, where you have specifically agreed to this, by email or similar technology (you can inform us at any time if you no longer require marketing communications or unsubscribe);
- (k) provide third parties with statistical information about our users (but those third parties will not be able to identify any individual user from that information);
- (l) deal with enquiries and complaints made by or about you relating to our website.
- (m) keep our website secure and prevent fraud; and
- (n) verify compliance with the terms and conditions governing the use of our website (including monitoring private messages sent through our website private messaging service).

3.3 If you submit personal information for publication on our website, we will publish and otherwise use that information in accordance with the license you grant to us.

3.4 Your privacy settings can be used to limit the publication of your information on our website and can be adjusted using privacy controls on the website.

3.5 We will not, without your express consent, supply your personal information to any third party for the purpose of their or any other third party's direct marketing.



3.6 Some of our financial transactions are handled through our payment services provider, TakePayments. You can review the provider's privacy policy at [<https://www.takepayments.com/privacy-policy/>]. We will share information with our payment services provider only to the extent necessary for the purposes of processing payments you make via our website, refunding such payments and dealing with complaints and queries relating to such payments and refunds.

3.7 Some of our financial transactions are handled through our payment services provider Tickettailor (view their privacy policy here - <https://www.tickettailor.com/privacy-policy/>) and transactions are processed through Paypal (view their privacy policy here - [paypal.com/uk/legalhub/privacy-full](https://www.paypal.com/uk/legalhub/privacy-full)). We will share information with our payment services provider only to the extent necessary for the purposes of processing payments you make via our website, refunding such payments and dealing with complaints and queries relating to such payments and refunds.

4. Disclosing Personal Information

4.1 We may disclose your personal information to any of our employees, officers, insurers, professional advisers, agents, suppliers, or subcontractors insofar as reasonably necessary for the purposes set out in this policy.

4.2 We may disclose your personal information to any member of our group of companies (this means our subsidiaries, our ultimate holding company and all its subsidiaries) insofar as reasonably necessary for the purposes set out in this policy.

4.3 We may disclose your personal information:

(a) to the extent that we are required to do so by law.

(b) in connection with any ongoing or prospective legal proceedings.

(c) in order to establish, exercise or defend our legal rights (including providing information to others for the purposes of fraud prevention and reducing credit risk).

(d) to the purchaser (or prospective purchaser) of any business or asset that we are (or are contemplating) selling; and

(e) to any person who we reasonably believe may apply to a court or other competent authority for disclosure of that personal information where, in our reasonable opinion, such court or authority would be reasonably likely to order disclosure of that personal information.

4.4 Except as provided in this policy, we will not provide your personal information to third parties.



5. Retaining Personal Information

5.1 This Section 5 sets out our data retention policies and procedure, which are designed to help ensure that we comply with our legal obligations in relation to the retention and deletion of personal information.

5.2 Personal information that we process for any purpose or purposes shall not be kept for longer than is necessary for that purpose or those purposes.

5.3 Notwithstanding the other provisions of this Section 5, we will retain documents (including electronic documents) containing personal data:

- (a) to the extent that we are required to do so by law.
- (b) if we believe that the documents may be relevant to any ongoing or prospective legal proceedings; and
- (c) in order to establish, exercise or defend our legal rights (including providing information to others for the purposes of fraud prevention and reducing credit risk).

6. Security of Personal Information

6.1 We will take reasonable technical and organisational precautions to prevent the loss, misuse, or alteration of your personal information.

6.2 We will store all the personal information you provide on our secure (password- and firewall-protected) servers.

6.3 All electronic financial transactions entered into through our website will be protected by encryption technology.

6.4 You acknowledge that the transmission of information over the internet is inherently insecure, and we cannot guarantee the security of data sent over the internet.

6.5 You are responsible for keeping the password you use for accessing our website confidential; we will not ask you for your password (except when you log in to our website).

7. Amendments

7.1 We may update this policy from time to time by publishing a new version on our website.

7.2 You should check this page occasionally to ensure you are happy with any changes to this policy.

7.3 We may notify you of changes to this policy [by email or through the private messaging system on our website].



8. Your Rights

8.1 You may instruct us to provide you with any personal information we hold about you; provision of such information will be subject to:

- (a) the payment of a fee (currently fixed at GBP 10.00); and
- (b) the supply of appropriate evidence of your identity [(for this purpose, we will usually accept a photocopy of your passport certified by a solicitor or bank plus an original copy of a utility bill showing your current address)].

8.2 We may withhold personal information that you request to the extent permitted by law.

8.3 You may instruct us at any time not to process your personal information for marketing purposes.

8.4 In practice, you will usually either expressly agree in advance to our use of your personal information for marketing purposes, or we will provide you with an opportunity to opt out of the use of your personal information for marketing purposes.

9. Third Party Websites

9.1 Our website includes hyperlinks to, and details of, third party websites.

9.2 We have no control over, and are not responsible for, the privacy policies and practices of third parties.

11. Cookies

11.1 Our website uses cookies.

11.2 A cookie is a file containing an identifier (a string of letters and numbers) that is sent by a web server to a web browser and is stored by the browser. The identifier is then sent back to the server each time the browser requests a page from the server.

11.3 Cookies may be either "persistent" cookies or "session" cookies: a persistent cookie will be stored by a web browser and will remain valid until its set expiry date, unless deleted by the user before the expiry date; a session cookie, on the other hand, will expire at the end of the user session, when the web browser is closed.

11.4 Cookies do not typically contain any information that personally identifies a user, but personal information that we store about you may be linked to the information stored in and obtained from cookies.

11.5 We use both session and persistent cookies on our website.



11.6 The names of the cookies that we use on our website, and the purposes for which they are used, are set out below:

Cookie Name	Used By	Description
__utma	Google Analytics	Stores the amount of visits of a user, the time of their first visit, the previous visit, and the current visit. It does not contain any personal information and is used only for analytical purposes.
__utmz	Google Analytics	This performance cookie stores where a user came from (eg. search engine, search keyword, link).
_ga and _gid	Google Analytics	Used to distinguish between website users in Google Analytics.
_gat_UA-XXXXXXXX-X (where the Xs are replaced by the Google Analytics ID number)	Google Analytics	Used to moderate calls to the Google Analytics service.
__unam	ShareThis	ShareThis Set as part of the ShareThis service and monitors "click-stream" activity, e.g. web pages viewed, navigation from page to page, time spent on each page etc. The ShareThis service only identifies a user if they have separately signed up with ShareThis for a ShareThis account and given them consent. Checks how long you stay on a site: when a visit starts, and ends. It does not contain any personal information and is used only for analytical purposes.
cc_cookie_accept	Website	Website Stores whether the user has accepted the cookie message or not.
ToggleStatus	Website	whether the user has hidden or shown the contacts filter search.
ASP.NET_SessionId	Website	Used for authenticating a user's session after logging in. Closes when you exit the browser.
ARRAffinity	Website	Tells our infrastructure which server to handle the request.
MemberLoggedIn	Website	A binary flag which stores whether a user is logged in or not.
ai_session and ai_user	Website	Tracks users as they navigate the website predominately for infrastructure performance insights.
DisplayName	Website	Keeps track of a donors preference to show their name during a Direct Debit

11.7 Most browsers allow you to refuse to accept cookies.

11.8 Blocking all cookies will have a negative impact upon the usability of many websites.

11.9 If you block cookies, you will not be able to use all the features on our website.



11.10 You can delete cookies already stored on your computer.

11.11 Deleting cookies will have a negative impact on the usability of many websites.

12.1 We are registered as a data controller with the UK Information Commissioner's Office.
